4. Question #20 - False - Must have NOCSAE tag or stamp on shin guards
5. Question #63 - False - Offside is determined when the ball is played
6. Question #13 - D - New rule this year. Cast no longer needs a doctor's note.
7. Question #19 - False - If not the injured player, must wait for legal substitution
8. Question #41 - False - Also must hand signal to center of field after signaling to stop clock
9. Question #26 - B - New rule for 2012. Goalie must have number on uniform
10. Question #73 - False - Soft Red (Yellow/Red) Together. Team shall substitute

#### Playoff Procedures:

#### On-Field Problems:

Coin Toss: Visiting team calls coin toss. Winner has choice of goal to defend, or kickoff. Loser must take the remaining choice.

Referees should watch what they say to players, coaches or spectators during play.

Lightning/Thunder: When seen/heard, play is suspended, all players take shelter in school, buses or cars. Wait 30 minutes from last incident. If coaches agree to not continue the match, leave match and notify BOCES of suspension. Otherwise wait out the storm, especially if the field has lights, as the game may be able to be resumed.
