# **Treasury Report:**

#### **Card Reporting:**

- Yellow Cards- reported on NCGSOA website by official who gave card within 24 hours of game.
- Red Cards-reported on NCGSOA website by official who gave cards and on Sportspack both officials must fill out the disqualification form by 12 pm the next day.
- It is important that you and your partner go over your match report, so your report mirror each other. If stories on forms are not the same BOCES will dismiss the card.
- Send Dave Poli a copy of your report so he can familiarize himself with the situation, email can be found on the NCGSOA website.
- If you fill out a red card form you do not follow up with BOCES, everything should go through David.

#### Moving Up in the Association:
