Elections:

- Bob McLaughlin will oversee the elections, interested in running for open positions you need to email Bob
- Open positions include Secretary/Treasurer and Member at Large
- Must be an active member to run for a position
- Voting will take place at the 9/13 meeting

Contract:

- Was approved with remedies at the last minute
- All playoffs will be 3 – person, so Varsity officials need to make themselves available

Ratings:

- Varsity Officials need to work 10 games to get a rating and 10 games to be eligible to work playoffs
- First year Varsity Officials are not eligible to work playoffs
- JV Officials need to work 8 games for two straight seasons to be considered to move up to Varsity

- Red Card information must also go to BOCES via [www.Section VIII. org](http://www.SectionVIII.org)
- You cannot enforce a red card from a prior game if the opposing coach tells you a player should not be on the field. They need to take it up with the coach coordinator

Uniforms:

- Orange is the primary color
- Officials must match in color and pants/shorts, but they do not have to match in sleeve length
